It is requested that the Commissioners Court approve purchase of Facilities Maintenance and Repair and Operations and Industrial Supplies, utilizing the Texas Multiple Award Schedule (TXMAS) Cooperative Contract #18-51V06, Countywide, with EVCO Partners, LP, d/b/a Burgoon Company, an authorized dealer of W.W. Grainger, Inc. at the per contract terms and discount off list price.

BACKGROUND

EVCO Partners, LP, d/b/a Burgoon Company, an authorized dealer of W.W. Grainger, Inc. was contacted and requested to submit pricing for Facilities Maintenance and Repair and Operations and Industrial Supplies under TXMAS Contract #18-51V06. The offer from EVCO Partners, LP, d/b/a Burgoon Company, an authorized dealer of W.W. Grainger, Inc. meets all specifications.

County departments use various hand and power tools, hardware supplies, janitorial supplies, safety supplies, material handling supplies, electrical supplies, plumbing supplies, lawn and garden supplies, and miscellaneous hardware equipment from EVCO Partners, LP, d/b/a Burgoon Company, an authorized dealer of W.W. Grainger, Inc. Examples of items purchased include circular saws, electric staple guns, paint brushes, cutting saw blades, drill bits, hoses, clamps, thermometers, power cords, flashlights, wrenches, doorknobs, batteries, gloves, etc. These tools and consumable supplies are utilized in the daily operations of the facilities management team throughout the Tarrant County buildings for maintenance and upkeep.

The TXMAS contract is effective through June 30, 2024.

TXMAS cooperative contracts are open to state and local government agencies in accordance with Government Code Title 7, Chapter 791, Subchapter C, Section 791.025, Contracts for Purchases

FISCAL IMPACT

Expenses for last year were approximately \$498,524.30. Orders are placed on an as-needed basis. The County's future costs will be determined by the orders provided on an as-needed basis. Funding is available in multiple accounts and cost centers.
