**SUBJECT: APPROVAL OF PROGRAM YEAR 2022 CONTINUUM OF CARE  
SUBRECIPIENT AGREEMENT BETWEEN TARRANT COUNTY  
AND TARRANT COUNTY SAMARITAN HOUSE, INC. FOR THE  
TBLA 15 PERMANENT SUPPORTIVE HOUSING PROGRAM –  
COMMUNITY DEVELOPMENT**

**COMMISSIONERS COURT ACTION REQUESTED**

It is requested that the Commissioners Court approve Program Year (PY) 2022 Continuum of Care (CoC) Subrecipient Agreement between Tarrant County and Tarrant County Samaritan House, Inc. for the TBLA 15 Permanent Supportive Housing (PSH) Program, Grant #TX0115L6T012215, in the amount of \$110,127.00.

**BACKGROUND**

In Fall 2022, Tarrant County, through the Community Development Department, in conjunction with the City of Fort Worth, the City of Arlington, and the Tarrant County Homeless Coalition (TCHC), applied for funding for the above-named project. The application was made in response to the U.S. Department of Housing and Urban Development’s (HUD’s) CoC Homeless Assistance Programs request for proposals.

On August 1, 2023, the Commissioners Court through Court Order #141359, approved the FY 2022 CoC Program Grant Agreement with HUD to provide Tarrant County with \$114,520.00 in grant funding to support the TBLA 15 PSH program. Tarrant County retains fifty percent (50%) of the \$8,786.00 Administrative Costs allowance within the grant budget.

If approved, Tarrant County will reimburse Tarrant County Samaritan House, Inc. for providing services to fifteen (15) households experiencing homelessness through the TBLA 15 PHS Program. These services include rental assistance, transportation, and general case management. Reimbursement will not exceed the following total amounts:

Operating Costs	\$105,734.00
Administrative Costs	\$ 4,393.00
Total	\$110,127.00

The agreement shall be for a term of twelve (12) months, commencing on November 1, 2023 and terminating on October 31, 2024.
