COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court approve renewal of Bid No. 2021-138, Annual Contract for Trash Removal Services, for the second and final optional twelve (12) month period at the same firm fixed prices.

BACKGROUND

On September 28, 2021, the Commissioners Court, through Court Order #136504, awarded Bid No. 2021-138, Annual Contract for Trash Removal Services, for Facilities Management, to Allied Waste Services of Fort Worth, LLC d/b/a Republic Services of Fort Worth.

The award was based upon low bid meeting specifications and contained options to renew for two (2) additional twelve (12) month periods.

This contract is for the collection and disposal of waste from Tarrant County buildings, including Precincts and WIC locations. Services include providing clean, functional containers with lids that close, backup capabilities to avoid disruption of services, lock fees, container rentals, and dual pickups for construction sites.

On October 19, 2021, the Commissioners Court, through Court Order #136632, rescinded Court Order #136504 to correct a pricing error, and re-awarded Bid No. 2021-138, Annual Contract for Trash Removal Services, for Facilities Management, to Allied Waste Services of Fort Worth, LLC d/b/a Republic Services of Fort Worth.

On August 30, 2022, the Commissioners Court, through Court Order #138991, approved renewal of Bid No. 2021-138, Annual Contract for Trash Removal Services, for Facilities Management, with Allied Waste Services of Fort Worth, LLC d/b/a Republic Services of Fort Worth.

The vendor notified Purchasing in writing that their prices will remain firm through September 30, 2024. Facilities Management notified Purchasing in writing that they are pleased with the vendor and want to renew.
