COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court approve two (2) FY 2023-2024 Texas Department of State Health Services (DSHS) HIV/Services (State Services) subrecipient contract renewals with AIDS Healthcare Foundation (AHF) and Tarrant County Preventive Medicine Clinic (PMC).

BACKGROUND

Tarrant County receives annual funding from DSHS in the form of grant contracts. The Texas DSHS State Services Grant will continue to fund health insurance, transportation, and referral for health care and support services in the Fort Worth Health Service Delivery Area (HSDA). The HSDA includes the Fort Worth/Arlington Transitional Grant Area (TGA) which includes the counties of Tarrant, Johnson, Parker and Wise, and the counties of Hood, Erath, Palo Pinto, and Somerville. Tarrant County HIV Administrative Agency administers the grant funding through subcontracts with community organizations that then deliver the necessary high-quality services.

AHF is a community-based medical clinic that delivers a variety of services to people living with HIV in Tarrant County and surrounding areas. Examples of services include medical care, prescription assistance, and referral for health care and support services.

PMC is an HIV medical clinic that is part of Tarrant County Public Health (TCPH) and has been delivering HIV services for more than twenty-five (25) years to people living with HIV in Tarrant County and surrounding areas. Examples of services include medical care, prescription assistance, medical case management, and referral for health care and support services.

On June 20, 2023, the Commissioners Court, through Court Order #141098, approved the FY 2023-2024 Texas DSHS State Services Grant Contract renewal in the amount of \$1,078,733.00.

The State Services project period and contract term is September 1, 2023 through August 31, 2024.

The recommended contracts are as follows:

AHF – Total reimbursement shall not exceed \$41,300.00.

PMC – Total reimbursement shall not exceed \$118,000.00.
