**COMMISSIONERS COURT ACTION REQUESTED**

It is requested that the Commissioners Court approve the FY 2023-2024 Health Resources and Services Administration (HRSA) Ryan White Part D (Part D) subrecipient contract with CAN Community Health, Inc. (CAN).

**BACKGROUND**

Tarrant County receives annual grant funding from HRSA to perform a variety of essential core and support services for HIV-positive individuals. The HRSA Ryan White Part D grant funding is used for the provision of family-centered care involving outpatient and ambulatory care for women, infants, children, and youth living with HIV/AIDS in the Fort Worth/Arlington Transitional Grant Area (TGA) which includes the counties of Tarrant, Hood, Johnson, and Parker. Tarrant County HIV Administrative Agency administers the grant funding through subrecipient subcontracts with community organizations that deliver the necessary high-quality services.

CAN is a community-based medical clinic that delivers a variety of services to people living with HIV in Tarrant County and surrounding areas. Examples of services include medical care, prescription assistance, oral health care, and case management.

On July 18, 2023, the Commissioners Court through Court Order #141259, approved the FY 2023-2024 HRSA Ryan White Part D Notice of Award (NOA) in the amount of \$566,009.00.

The Part D project period is August 1, 2023 through July 31, 2026. The grant budget period will remain August 1, 2023 through July 31, 2024.

The recommended contract is as follows:

CAN Community Health, Inc. – Total reimbursement shall not exceed \$464,646.00.
