COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court approve renewal of RFP No. 2021-130, Transportation Services for Juvenile Justice Alternative Education Program, for the second optional twelve (12) period at the same contract terms and approve contract.

BACKGROUND

On August 24, 2021, the Commissioners Court, through Court Order #136173, awarded RFP No. 2021-130, Transportation Services for Juvenile Justice Alternative Education Program, for Juvenile Services, to Durham School Services.

The award was based upon the evaluation criteria set forth in the RFP specifications and contained options to renew for three (3) additional twelve (12) month periods.

Tarrant County Juvenile Justice Alternative Education Program (JJAEP) provides education services for students expelled from Tarrant County school districts. The contract with Durham School Services is needed to provide transportation services for students in Tarrant County that attend JJAEP.

On August 16, 2022, the Commissioners Court, through Court Order #138868, approved the renewal of RFP No. 2021-130, Transportation Services for Juvenile Justice Alternative Education Program, to Durham School Services.

The vendor notified Purchasing in writing that they will extend the same contract terms through August 31, 2024. Juvenile Services notified Purchasing in writing that they are pleased with the vendor and want to renew. The Tarrant County Juvenile Services Board approved the contract renewal on July 19, 2023.

Therefore, it is the joint recommendation of Juvenile Services, Tarrant County Juvenile Services Board, and Purchasing that the Commissioners Court approve the renewal of RFP No. 2021-130, Transportation Services for Juvenile Justice Alternative Education Program, for another twelve (12) month period.
