SUBJECT: APPROVAL OF AMENDMENT NO. 1 TO THREE FISCAL YEAR 2023-2024 TEXAS DEPARTMENT OF STATE HEALTH SERVICES RYAN WHITE TREATMENT EXTENSION ACT PART B SUBRECIPIENT CONTRACTS WITH AIDS HEALTHCARE FOUNDATION, TARRANT COUNTY HOSPITAL DISTRICT, AND TARRANT COUNTY PREVENTIVE MEDICINE CLINIC – HIV ADMINISTRATIVE AGENCY

COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court approve Amendment No. 1 to three (3) Fiscal Year 2023-2024 Texas Department of State Health Services (DSHS) Ryan White Treatment Extension Act Part B (Part B) Subrecipient Contracts with AIDS Healthcare Foundation (AHF), Tarrant County Hospital District (TCHD), and Tarrant County Preventive Medicine Clinic (PMC).

BACKGROUND

Texas DSHS provides annual Ryan White Part B grant funding for the provision of essential core medical and support services to people living with HIV.

On February 7, 2023, the Commissioners Court, through Court Order #140209, approved the FY 2023-2024 Texas DSHS Ryan White Part B HIV Services Grant Contract renewal in the amount of \$1,320,878.00.

AHF is a community-based medical clinic that delivers a variety of services to people living with HIV in Tarrant County and surrounding areas. Examples of services include medical care, prescription assistance, and referral, for health care and support services.

TCHD has been delivering HIV services for more than twenty-five (25) years. JPS is the safety-net hospital in Tarrant County that provides quality health and mental health care services to the area's most vulnerable populations. Examples of services provided through JPS Healing Wings HIV Clinic include medical care, prescription assistance, oral health care, mental health, case management, and referral for health care and support services.

PMC is an HIV medical clinic that is part of and located within Tarrant County Public Health (TCPH). PMC delivers a variety of services to people living with HIV in Tarrant County and surrounding areas. Examples of services include medical care, prescription assistance, medical case management, and referral for health care and support services.

On April 18, 2023, the Commissioners Court, through Court Order #140700, approved the FY 2023-2024 Subrecipient Contract renewal with AHF for reimbursement not to exceed \$47,625.00 and PMC for reimbursement not to exceed \$51,927.00.

On May 2, 2023, the Commissioners Court, through Court Order #140785, approved the FY 2023-2024 Subrecipient Contract renewal with TCHD for reimbursement not to exceed \$176,518.00.

With approval of Amendment No. 1 to the Subrecipient Agreements, the contract term will extend from August 31, 2023 to March 31, 2024. This change in contract term is at the direction of DSHS.

The Part B Grant Project period is April 1, 2022 through March 31, 2024. The term of this contract is April 1, 2023, through March 31, 2024.
