**BACKGROUND**

On November 22, 2022, the Commissioners Court, through Court Order #139767, awarded Bid No. 2023-016, Annual Contract for Police Package Vehicles, Countywide, to the following vendors:

The awards were based upon low bid meeting specifications and contained an option to renew for one (1) additional twelve (12) month period.

This agreement is for the County to purchase police package vehicles for the Sheriff's Office to use during high-speed chases, issuing tickets, quickly reaching incident scenes, transporting law-breaking citizens, and detaining suspects while establishing a police presence and providing visible crime deterrence. Purchases are made using the Transportation Department's general ledger and grant use accounts. These vehicles are specifically designed by the manufacturer to handle high-speed pursuits. They contain parts and/or components that are not in the general public vehicles of the same make and model which could be a Ford Explorer or Dodge Durango.

Sam Pack's Five Star Ford, Grapevine DCJ, LLC, Holiday-Graham CDJR, LLC, Holiday Chevrolet, and Holiday Ford elected not to renew. The remaining vendors notified Purchasing in writing that their prices will remain firm through December 3, 2024. Transportation Services notified Purchasing in writing that they are pleased with the vendors and want to renew.

Therefore, it is the joint recommendation of Transportation Services and Purchasing that the Commissioners Court approve renewal of Bid No. 2023-016, Annual Contract for Police Package Vehicles, for another twelve (12) month period.
