**SUBJECT: APPROVAL OF FISCAL YEAR 2024 COMMUNITY SERVICE PROVIDER CONTRACT WITH MY HEALTH MY RESOURCES OF TARRANT COUNTY FOR THE PROVISION OF YOUTH ADVISORY COMMITTEE SERVICES AND YOUTH LEADERSHIP DEVELOPMENT SERVICES THROUGH THE TEXAS DEPARTMENT OF FAMILY AND PROTECTIVE SERVICES PREVENTION AND EARLY INTERVENTION PROGRAM COMMUNITY YOUTH DEVELOPMENT GRANT**

**COMMISSIONERS COURT ACTION REQUESTED**

It is requested that the Commissioners Court approve the FY 2024 Community Service Provider Contract with My Health My Resources of Tarrant County (MHMRTC) for the provision of Youth Advisory Committee (YAC) services and Youth Leadership Development (YLD) services through the Texas Department of Family and Protective Services (DFPS) Prevention and Early Intervention (PEI) Community Youth Development (CYD) Grant for youth participating in the Tarrant County Public Health Department (TCPH) CYD Program.

**BACKGROUND**

Since 1995, through the CYD program, DFPS PEI has provided funding and technical assistance to give community-based organizations the opportunity to foster positive youth development and build healthy families and resilient communities. CYD provides services in zip codes with high incidences of juvenile crime. Communities prioritize and fund specific prevention services to address community-level needs.

In April 1996, Tarrant County began the TCPH CYD Program through grant funds provided by the DFPS PEI CYD Grant Program to curb juvenile crime in the 76106 and 76164 zip codes.

On August 1, 2023, the Commissioners Court, through Court Order #141391, approved Notice of Award, No. 2024-01, from DFPS to award Tarrant County \$525,000.00 in FY 2024 PEI CYD Grant funding, and an additional \$150,000.00 in FY 2024 Community-Based Child Abuse Prevention Innovation Grant funding under the statutory authority of the American Rescue Plan Act (ARPA). Total award is \$675,000.00. The grant funding period for this award is September 1, 2023 through August 31, 2024.

The MHMRTC YAC offers monthly community service learning projects aimed at developing youth leadership skills. Youth are invited to join YAC after participation in other MHMRTC programs. The Youth Engagement Director (YAC Coordinator) works to build participant's leadership skills through reinforcement of the activities from YLD. MHMRTC has received this funding since 2022.

With approval of this contract, Tarrant County will reimburse MHMRTC an amount not to exceed \$40,072.80 in FY 2024 PEI CYD Grant funding for the provision of YAC and YLD services. The funding period for the Contract is September 1, 2023 through August 31, 2024.

The Contract has been approved as to form by the Criminal Attorney's Office.

### **FISCAL IMPACT**

Funding in the amount of \$40,072.80 will be paid from grant fund allocation in F0040-2024.

There is no match requirement, indirect cost, or operating subsidy required for this grant.
