COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court approve the FY 2023-2024 Texas Department of State Health Services (DSHS) HIV/Services (State Services) Subrecipient Contract renewal with Tarrant County Hospital District (TCHD).

BACKGROUND

Tarrant County annually receives funding from DSHS in the form of grant contracts. The Texas DSHS State Services Grant funds health insurance, transportation, and referrals for health care and support services in the Fort Worth Health Service Delivery Area (HSDA). HSDA is a geographic service area established by the DSHS for the purposes of allocating federal and state funds for HIV Services.

On June 20, 2023, the Commissioners Court, through Court Order #141098, approved the FY 2023-2024 Texas DSHS State Services Grant Contract renewal in the amount of \$1,078,733.00 for the project period of September 1, 2023 through August 31, 2024.

TCHD has been delivering HIV services for more than twenty-five (25) years. JPS is the safety-net hospital in Tarrant County that provides quality health and mental health care services to the area’s most vulnerable populations. Examples of services provided through JPS Healing Wings HIV Clinic include medical care, prescription assistance, oral health care, mental health, and case management.

The term of this Subrecipient Contract is September 1, 2023 through August 31, 2024.

The recommended renewal is as follows:

TCHD – Total reimbursement shall not exceed \$662,567.00.
