It is requested that the Commissioners Court approve Amendment No. 1 for RFP No. 2022-054, Annual Contract for Reconnecting Youth Program, for Juvenile Services, with Youth Advocate Programs, Inc., at the per contract terms.

**BACKGROUND**

On April 22, 2022, the Commissioners Court, through Court Order #137918, awarded RFP No. 2022-054, Annual Contract for Reconnecting Youth Program, for Juvenile Services, to Youth Advocate Programs, Inc.

On August 30, 2022, the Commissioners Court, through Court Order #138996, approved FY22 Amendment No. 1 for RFP No. 2022-054, Annual Contract for Reconnecting Youth Program, for Juvenile Services, to Youth Advocate Program, Inc.

On September 27, 2022, the Commissioners Court, through Court Order #139297, approved FY22 Amendment No. 2 for RFP No. 2022-054, Annual Contract for Reconnecting Youth Program, for Juvenile Services, to Youth Advocate Program, Inc.

On November 22, 2022, the Commissioners Court, through Court Order #139770, approved renewal of RFP No. 2022-054, Annual Contract for Reconnecting Youth Program, for Juvenile Services, to Youth Advocate Program, Inc.

Reconnecting Youth Program is a state mandated life skills program for students attending the Juvenile Justice Alternative Education Program (JJAEP).

The contract amendment revises Section 2 of the original contract, which extends the August 31, 2023 contract end date to November 30, 2023. In addition, the amendment revises Section 4.1 of the original contract by increasing the total not-to-exceed amount of the contract from \$89,946.33 to \$112,431.33, an increase of \$22,485.00.
