**COMMISSIONERS COURT ACTION REQUESTED**

It is requested that the Commissioners Court approve renewal of RFP No. 2022-128, Annual Contract for Family Preservation Program, for Juvenile Services, for the first optional twelve (12) month period at the same contract terms and approve contract.

**BACKGROUND**

On August 16, 2022, the Commissioners Court, through Court Order #138860, awarded RFP No. 2022-128, Annual Contract for Family Preservation Program, for Juvenile Services, to Lena Pope Home, Inc.

The award was based upon evaluation criteria set forth in the RFP specifications and contained options to renew for two (2) additional twelve (12) month periods.

The contract is needed to provide comprehensive intervention services, including clinical assessment and counseling, skills-based training coordination or resources, intensive in-home services, and 24-hour crisis intervention services to youth/families under the jurisdiction of Tarrant County Juvenile Services.

The vendor notified Purchasing in writing that they will extend the same contract terms through September 30, 2024. Juvenile Services notified Purchasing in writing that they are pleased with the vendor and want to renew. The Tarrant County Juvenile Services Board approved the contract renewal on August 16, 2023.

Therefore, it is the joint recommendation of Juvenile Services, Tarrant County Juvenile Services Board, and Purchasing that the Commissioners Court approve renewal of RFP No. 2022-128, Annual Contract for Commissioners Court approve renewal of RFP No. 2022-128, Family Preservation Program, for another twelve (12) month period.

The contract is attached for approval and signature. The Criminal District Attorney's Office reviewed the contract as to form.
