The awards were based upon low bid meeting specifications and contained options to renew for one (1) additional twelve (12) month period.

This contract is to provide necessary hygiene supplies and linens to comply with jail standards for inmates and Juvenile Services.

The vendors notified Purchasing in writing that their prices will remain firm through November 17, 2024. The Sheriff's Office and Juvenile Services notified Purchasing in writing that they are pleased with the vendors and want to renew.

Therefore, it is the joint recommendation of the Sheriff's Office, Juvenile Services, and Purchasing that the Commissioners Court approve renewal of Bid No. 2023-006, Annual Contract for Inmate Hygiene Supplies, for another twelve (12) month period.

FISCAL IMPACT

Expenses for last year were approximately \$260,523.62. The County's future cost will be determined by orders placed on an as-needed basis. Funding is available in the following accounts:
