SUBJECT: **PERMISSION TO TAKE BIDS/RFPs**

COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court grant permission to take Bids/RFPs for the following:

a. Sale of Surplus Electronic and Computer Equipment for Fiscal Year 2024

Estimated Value - This award constitutes revenue to Tarrant County

The Information Technology Department conducts ongoing technology refreshment (tech refresh) for the County, resulting in a surplus of outdated electronic and computer equipment. The sale of excess equipment is requested through a competitive bid. The primary department contact for this item is Brian Redmond, IT Resources Manager.

b. Purchase of 11-Wheel Pneumatic Compactors

Estimated Value - \$282,880.00

Funding for this item was included in the FY2024 Budget.

The purpose of this is for the purchase of two (2) 11-wheel pneumatic compactors to spread and compact materials in road construction projects. This will be purchased by Precinct 4 Maintenance Facility. The primary contact for these items is Ned Pyle.

c. Purchase of Motor Graders

Estimated Value - \$680,632.00

Funding for this item was included in the FY 2024 Budget.

The purpose of this is to set the grade of County roads and spread materials. This will be purchased by Maintenance Precinct 4. The primary department contact is Ned Pyle.

d. Purchase of Rubber Tire Wheel Loaders

Estimated Value - \$500,000.00

Funding for this item was included in the FY 2024 Budget.

The purpose of this is to load road materials into trucks. This will be purchased by Maintenance Precincts 2 and 4. The primary department contacts are Jason Murphy and Ned Pyle.

e. Purchase of Asphalt Distributor Truck

Estimated Value - \$570,000.00

Funding for this item was included in the FY 2024 Budget.

The purpose of this purchase is to distribute liquid tack onto the roads before the asphalt is laid. This will be purchased by Maintenance Precinct 4. The primary department contact is Ned Pyle.

f. Purchase of Trailer Mounted Wet Jet and Vacuum Excavators

Estimated Value - \$191,000.00

Funding for this item was included in the FY 2024 Budget.

The purchase of this is for the removal of water run-off in worksites and excavation of blockage. This will be purchased by Maintenance Precincts 2 and 4. The primary department contacts are Jason Murphy and Ned Pyle.
