**SUBJECT: APPROVAL OF AMENDMENT NO. 1 TO THE PROGRAM YEAR  
2022 CONTINUUM OF CARE SUBRECIPIENT AGREEMENT  
BETWEEN TARRANT COUNTY AND THE SALVATION ARMY –  
MABEE CENTER FOR THE TBLA 114 RAPID REHOUSING  
PROGRAM – COMMUNITY DEVELOPMENT**

**COMMISSIONERS COURT ACTION REQUESTED**

It is requested that the Commissioners Court approve Amendment No. 1 to the Program Year (PY) 2022 Continuum of Care (CoC) Subrecipient Agreement between Tarrant County and The Salvation Army – Mabee Center for the TBLA 114 Rapid Rehousing (RRH) Program, Grant #TX0113L6T012215.

**BACKGROUND**

On May 16, 2023, the Commissioners Court, through Court Order #140875, approved a Subrecipient Agreement between Tarrant County and The Salvation Army – Mabee Center to provide \$65,000.00 in interim funding for the TBLA 114 RRH Program to ensure the continuity of services.

On June 22, 2023, Tarrant County Community Development received a grant award from the U.S. Department of Housing and Urban Development (HUD) for funds in the amount of \$1,288,838.00 for the TBLA 114 TBLA 114 Homeless Assistance Program, which is administered through subrecipient agreements with AIDS Outreach Center, Center for Transforming Lives, SafeHaven of Tarrant County, The Salvation Army – Arlington, and The Salvation Army – Mabee Center. Tarrant County retains fifty percent (50%) of the \$106,716.00 Administrative Costs allowance within the grant budget. The awarded grant funds will be used to reimburse Tarrant County for the use of interim funds referenced above and provide the remaining award balance to the subrecipients.

With approval of Amendment No. 1, Tarrant County will provide The Salvation Army – Mabee Center with \$249,708.00 in additional TBLA 114 grant funds, bringing the total grant award to \$314,708.00. Funding will be used to support the TBLA 114 RRH Program, which provides services to households experiencing homelessness within Tarrant County. These services include rapid rehousing, rental assistance, transportation, and general case management. Reimbursement will not exceed the following amounts:

Rental Assistance	<u>\$300,000.00</u> ( <i>\$65,000.00 in interim funding has been disbursed</i> )
Total	\$314,708.00
