**BACKGROUND**

On September 28, 2021, the Commissioners Court, through Court Order #136503, awarded RFP No. 2021-137, Annual Contract for Jail System Food Services, for the Sheriff's Department, to the following vendors at the price per meal listed in the sliding scale of RFP specifications:

Alternate	Trinity Services Group, Inc., d/b/a Trinity Corrections Services, Inc. in Texas

On October 19, 2021, the Commissioners Court, through Court Order #136641, approved acceptance of payment and performance bonds for Five Star Correctional Services, Inc.

On April 26, 2022, the Commissioners Court, through Court Order #138012, approved cancellation of the primary award to Five Star Correctional Services, Inc. and awarded to the next proposals meeting specifications and approved contract:
