**SUBJECT: APPROVAL OF RENEWAL AND AMENDMENT NO. 2 TO THE INTERLOCAL AGREEMENT WITH THE CITY OF RIVER OAKS RELATED TO THE ROBERTS CUT-OFF ROAD RECONSTRUCTION PROJECT FROM SKYLINE DRIVE TO THE NORTH CITY LIMITS AND FROM BLACKSTONE DRIVE TO RIVER OAKS BOULEVARD (SH 183) - 2006 TRANSPORTATION BOND PROGRAM**

**COMMISSIONERS COURT ACTION REQUESTED**

It is requested that the Commissioners Court approve Renewal and Amendment No. 2 to the Interlocal Agreement (ILA) related to the City of River Oaks to provide funding through the 2006 Transportation Bond Program (TBP) related to the Roberts Cut-Off Road reconstruction project from Skyline Drive to the North City Limits and from Blackstone Drive to River Oaks Boulevard (SH 183) in Precinct 4.

**BACKGROUND**

On September 7, 2021, the Commissioners Court, through Court Order #136281, entered into an ILA with the City of River Oaks for financial support of up to \$453,281.00 related to the Roberts Cut-Off Road reconstruction project from Skyline Drive to the North City Limits and from Blackstone Drive to River Oaks Boulevard (SH 183).

On November 1, 2022, the Commissioners Court, through Court Order #139605, approved Renewal and Amendment No. 1 to the ILA to renew the expiration date to September 30, 2023, and continue 2006 TBP funding for this project.

The project construction is incomplete, and not all the requests for reimbursements are submitted by the expiration date of the current ILA.

With approval, Renewal and Amendment No. 1 will extend the expiration date to September 30, 2024, to continue the 2006 TBP funding for this project. The 2006 TBP funding for this project will be provided through discretionary funds from Precinct 4.

This ILA Renewal and Amendment No. 2 is attached and has been reviewed by the Auditor's Office and approved as to form by the Criminal District Attorney's Office. In addition, this ILA Renewal and Amendment No. 2 has been approved by the City of River Oaks through Resolution No. 1110-2023.
