**SUBJECT: APPROVAL OF AN INTERLOCAL AGREEMENT WITH THE CITY  
OF RIVER OAKS RELATED TO THE RESIDENTIAL STREETS  
RECONSTRUCTION OF YALE STREET - 2021 TRANSPORTATION  
BOND PROGRAM**

**COMMISSIONERS COURT ACTION REQUESTED**

It is requested that the Commissioners Court approve an Interlocal Agreement (ILA) with the City of River Oaks related to the Residential Streets Reconstruction of Yale Street to provide funding through the 2021 Transportation Bond Program (TBP).

**BACKGROUND**

On August 3, 2021, the Commissioners Court, through Court Order #136021, accepted a prioritized list of thirty-three (33) projects recommended by the participating cities and the Court-appointed Project Evaluation Committee (PEC) for funding in the Call for Projects category of the 2021 TBP. The reconstruction of the Yale Street project is included in the approved list of projects.

With voter approval of Proposition A on November 2, 2021, and with Commissioner Court approval of the issuance of bond funds on May 24, 2022, through Court Order #138185, the County is now proceeding with the execution of an ILA with the City of River Oaks related to Residential Streets Project, Yale Street Reconstruction. This project will be funded through the 2021 TBP, Call for Projects category.

On June 6, 2023, the Commissioners Court, through Court Order #141058, approved Amendment No. 1 to the thirty-three (33) projects recommended by the participating cities and the Court-appointed PEC to revise the project list and the allocated funds.

On July 18, 2023, the Commissioners Court, through Court Order #141326, approved Amendment No. 2 to the thirty-three (33) projects recommended by the participating cities and the Court-appointed PEC to revise the project list and the allocated funds.

This project will consist of the construction (or reconstruction) of Yale Street from Roberts Cut-Off Road to River Oaks Boulevard. The purpose of the project is to overlay a new layer of asphalt to prevent further weather cracking and to recover traffic control expenditures related to this project.

This ILA is attached and has been reviewed by the Auditor's Office and approved as to form by the Criminal District Attorney's Office. In addition, this ILA has been approved by the City of River Oaks through Resolution No. 1111-2023.
