It is requested that the Commissioners Court approve RFO No. F2024042, Purchase of SAP SuccessFactors Software Licenses, utilizing General Services Administration (GSA) Contract #47QSWA18D008F, for Information Technology, with Carahsoft Technology Corporation for \$79,269.60.

BACKGROUND

Two hundred eighty-six (286) vendors were contacted and requested to submit written offers for RFO No. F2024042, Purchase of SAP SuccessFactors Software Licenses, under cooperative contracts.

Three (3) offers and one (1) no-bid were received. The low offer received from Carahsoft Technology Corporation meets all specifications and is acceptable to Information Technology.

SAP SuccessFactors software licenses covered under this purchase include Employee Central, Recruiting, and Onboarding. These software licenses are used as a learning solution for County personnel to book onsite and online classes.

GSA Schedules 70 and 84 provide agencies with information technology equipment, maintenance, software, and professional services. The schedule is currently open for use by federal, state, and local governmental agencies. State and local government agencies are able to purchase from Schedule 70 by way of cooperative purchasing.

The GSA contract expires on August 21, 2028.

The term of contract is twelve (12) months, effective December 1, 2023.
