COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court approve CentralSquare Technologies, LLC as sole source for ONESolution CAD (Computer-Aided Dispatch) software and service, for the Sheriff's Office.

BACKGROUND

CentralSquare Technologies, LLC provided the Purchasing Agent documentation to substantiate the fact that ONESolution is a sole source product, manufactured, sold, serviced, and distributed exclusively by CentralSquare Technologies, LLC. There are no other agents or dealers authorized to resell this product.

CentralSquare ONESolution is used by the Sheriff's Office for computer-aided dispatch, law enforcement communications, records management, personnel management, equipment and order issuance, incident based reporting, field training management, patrol and mobile dispatching, and courtesy patrol communication. The product and its modules serve over 1,300 Sheriff's officers and associated users as well as Constables and the Fire Marshal's Office.

Under the County Purchasing Act, exemptions to the competitive bidding requirements are allowed for certain types of purchases. The statutes require that the Purchasing Agent advise the Commissioners Court of the existence of only one (1) source, with such notice to be entered into the minutes of the Court.

Accordingly, the above item has been determined to be sole source under the County Purchasing Act 262.024(a)(7) as follows:

- “(7) an item can be obtained from only one (1) source, including:
(A) items for which competition is precluded because of the existence of patents, copyrights, secret processes, or monopolies”.

FISCAL IMPACT

Expenses for last year were approximately \$398,852.57. Funding will be requested in the FY 2025 budget requests.
