COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court award RFP No. F2024085, Annual Contract for Website Quality Management Product, for Information Technology, to Silktide Inc. at the per contract terms.

BACKGROUND

Notice of the County's intent to bid was advertised in local newspapers, as required by State statute, and posted on the Internet, the Arlington Black Chamber of Commerce, the Fort Worth Hispanic Chamber of Commerce, the Fort Worth Metropolitan Black Chamber of Commerce, and the Tarrant County Asian American Chamber of Commerce. Three hundred fifty-five (355) vendors were contacted and requested to participate in this proposal process. All documents pertaining to this RFP were posted on the Tarrant County website and were downloaded by interested parties. A pre-proposal conference held on March 20, 2024, was attended by two (2) vendors as well as representatives from Information Technology and Purchasing. Two (2) proposals and two (2) no-bids were received.

Proposals were evaluated by Information Technology and Purchasing representatives. Evaluations were based upon the criteria and processes set forth in the RFP.

The top scoring vendor was invited to provide a demonstration on May 15, 2024. The evaluation committee then rescored based upon the criteria and processes set forth in the RFP specifications.

A Best and Final Offer (BAFO) was then requested from the highest scoring vendor which resulted in no reduction in price.

The proposal received from Silktide Inc. meets all specifications and is acceptable to Information Technology.

The term of the contract is twelve (12) months, effective July 2, 2024, with two (2) options for renewal periods of twelve (12) months each.

The product will automatically detect accessibility violations and common quality issues such as broken links or misspellings and will integrate with Adobe AEM 6.5 to automatically enforce the County's content standard policies.

Therefore, it is the joint recommendation of Information Technology and Purchasing that RFP No. F2024085, Annual Contract for Website Quality Management Product, be awarded to Silktide Inc. at the per contract terms.
