COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court award Bid No. F2024120, Purchase of Haul Truck, for Precinct 2, to Premier Truck Group at the per unit price.

BACKGROUND

Notice of the County's intent to bid was advertised in local newspapers, as required by State statute, and posted on the Internet, the Arlington Black Chamber of Commerce, the Fort Worth Hispanic Chamber of Commerce, the Fort Worth Metropolitan Black Chamber of Commerce, and the Tarrant County Asian American Chamber of Commerce. Six hundred eighty-four (684) vendors were contacted and requested to participate in this bid process. All documents pertaining to this bid were posted on the Tarrant County website and were downloaded by interested bidders. A pre-bid conference held on June 5, 2024 was attended by two (2) vendors as well as representatives from Precinct 2 and Purchasing. Three (3) bids and three (3) no-bids were received.

The low bid received from Premier Truck Group meets all specifications and is acceptable to Precinct 2.

The purpose of this purchase is to haul road building equipment to various job sites throughout Tarrant County.

Therefore, it is the joint recommendation of Precinct 2 and Purchasing that Bid No. F2024120, Purchase of Haul Truck, be awarded to Premier Truck Group at the per unit price.
