COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioner Court approve the appointment of Dr. Catherine A Colquitt and Dr. Kenton K. Murthy as Tarrant County Health Authority Designees (HAD) in accordance with Section 121.0331 of the Texas Health and Safety Code. Dr. Catherine A. Colquitt will act as primary HAD and Dr. Kenton K. Murthy as secondary HAD. In addition, it is requested the Commissioners Court approve the adoption of procedures for the service of the HADs.

BACKGROUND

On June 4, 2024, the Commissioners Court, through Court Order # 143217, appointed Dr. Brian Byrd as the Tarrant County Health Authority effective July 1, 2024. Texas Health & Safety Code section 121.0331 permits a Health Authority to delegate powers or duties imposed on a Health Authority to a properly qualified physician employed by the county's local health department. Both Drs. Colquitt and Murthy meet the qualifications to serve as HAD as they are employed by the Tarrant County Public Health Department, are competent physicians with reputable professional standings who are legally qualified to practice medicine in Texas and are residents of Texas. Per Health & Safety Code section 121.0331(b)(2), a HAD designee must be appointed in the same manner as a Health Authority. The Commissioners Court appointment of Drs. Colquitt and Murthy are therefore necessary for service as HADs.

As part of the delegation process, Health & Safety Code section 121.0331(e) requires the Commissioners Court to "adopt procedures for the service of the designee as health authority" to "prevent duplication of authority between the health authority and the designee and provide notice to the department when authority is transferred."

These appointments shall be effective July 16, 2024 and will continue through June 31, 2026.
