COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court approve the Amended and Restated Pay Connexion Services Terms between Tarrant County and JPMorgan Chase Bank for credit card services for the Tarrant County Tax Assessor-Collector Office.

BACKGROUND

JPMorgan Chase Bank provides credit card services to the Tarrant County Tax Assessor-Collector Office to be able to accept payments via Web and telephone for property tax payments, motor vehicle payments, Vehicle Inventory Tax (VIT), and liquor, beer and wine tax.

On November 8, 2016, the Commissioners Court, through Court Order #123944, approved the Amended and Restated Pay Connexion Services Terms with JPMorgan Chase Bank. The service term became effective on the start date and continued for one (1) year and may be renewed for two (2) successive one (1) year terms.

On October 15, 2019, the Commissioners Court, through Court Order #131365, approved the Second Amendment to incorporate reductions to the credit card fees set forth in Exhibit B (fee schedule) of the service terms.

On October 29, 2019, the Commissioners Court, through Court Order #131487, approved the Third Amendment to replace Section 8.1 of the Service Terms section.

With approval, the current Amended and Restated Pay Connexion Services Terms will be extended through July 12, 2024, to prevent any possible interruptions of payment services during the Half-Pay collection period ending on July 1, 2024. This step was proactively initiated due to technical issues that can arise during the transition of POS credit and debit card services. JPMorgan Chase Bank supports the extension of this agreement to assist the approximately 44,000 accounts currently utilizing the Half-Pay option for payment of ad valorem. Such web-based application portion of this service will be terminated effective July 15, 2024.

The Criminal District Attorney's Office has approved this Agreement as to form.

There is no fiscal impact associated with this item.


