The reassignment of the Courts located on the 7th Floor of the Tim Curry Criminal Justice Center is as follows:

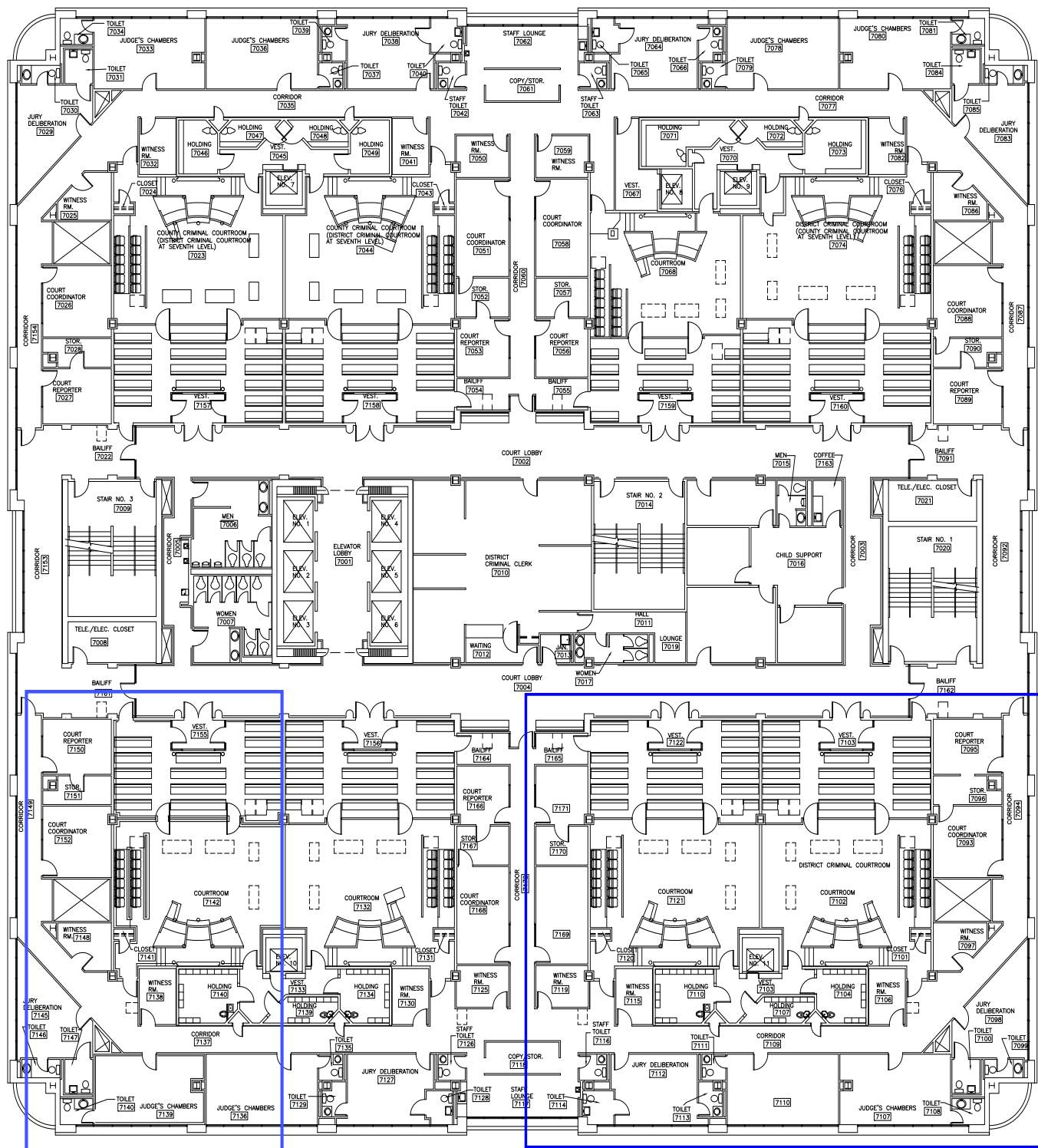

- Reassign Courtroom 7121 (currently assigned as Auxiliary Trial Room E) located on the southeast court suite to the 396th District Court, Judge George Gallagher.
- Reassign Courtroom 7142 (currently assigned to County Criminal Court No. 7) located on the southwest court suite to Auxiliary Trial Room E.

Both Judge Starnes and Judge Gallagher have agreed to the reassignment of courtrooms.
