### **COMMISSIONERS COURT ACTION REQUESTED**

It is requested that the Commissioners Court award RFP No. F2024146, Annual Contract for CDL Training, Countywide, to the following vendors at the per contract terms:

Primary	STVI-AAI Education, Inc. d/b/a Ancora Education
Secondary	On Track Truck Driving School

### **BACKGROUND**

Notice of the County's intent to bid was advertised in local newspapers, as required by State statute, and posted on the Internet, the Arlington Black Chamber of Commerce, the Fort Worth Hispanic Chamber of Commerce, the Fort Worth Metropolitan Black Chamber of Commerce, and the Tarrant County Asian American Chamber of Commerce. Six hundred twenty-four (624) vendors were contacted and requested to participate in this proposal process. All documents pertaining to this RFP were posted on the Tarrant County website and were downloaded by interested parties. A pre-proposal conference held on June 12, 2024 was attended by four (4) vendors as well as representatives from the four (4) Maintenance Precincts, Facilities Management, the Sheriff's Office, and Purchasing. Three (3) proposals were received.

Proposals were evaluated by the four (4) Maintenance Precincts, Facilities Management, the Sheriff's Office, and Purchasing representatives. Evaluation was based upon the criteria and processes set forth in the RFP.

A Best and Final Offer was requested from the highest scoring vendor which resulted in a reduction of \$5,905.00 from the originally proposed price of \$92,900.00. A Best and Final Offer was requested from the secondary vendor but they did not return an offer.

The proposals received from the vendors listed above meet all specifications and are acceptable to the four (4) Maintenance Precincts, Facilities Management and the Sheriff's Office.

The term of the contract is twelve (12) months, effective August 29, 2024, with two (2) options for renewal periods of twelve (12) months each.
