COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court approve Amendment No. 4 to the Program Year (PY) 2020 Emergency Solutions Grant–CARES Act (ESG-CV) Program Contract between Tarrant County and Tarrant County Hands of Hope for Street Outreach Essential Services related to the COVID-19 response.

BACKGROUND

Hands of Hope provides Street Outreach Essential Services which meets the immediate needs of people experiencing homelessness in unsheltered locations by connecting them with emergency shelter, housing, or critical services, and providing them with urgent, non-facility-based care.

On March 27, 2020, the Coronavirus Aid, Relief, and Economic Security (CARES) Act was signed into law, providing supplemental funding allocations to Tarrant County as an Urban Entitlement County.

On May 5, 2020, the Commissioners Court, through Court Order #132721, approved the 2020 Action Plan which included provisions for the Tarrant County ESG-CV program.

On March 9, 2021, the Commissioners Court, through Court Order #134947, approved the initial contract between Tarrant County and Tarrant County Hands of Hope for funding in the amount of \$111,090.00 for the provision of Street Outreach Services and Supply Expenses related to the COVID-19 response.

On April 12, 2022, the Commissioners Court, through Court Order #137883, approved Amendment No. 1, increasing funding to \$141,090.00 and extending the contract through September 30, 2022 to align with guidance received from HUD.

On September 13, 2022, the Commissioners Court, through Court Order #139092, approved Amendment No. 2, extending the contract through September 30, 2023 to align with guidance received from HUD.

On November 1, 2022, the Commissioners Court, through Court Order #139558, approved Amendment No. 3, increasing funding to \$309,090.00 and extending the contract through June 30, 2024 to align with guidance received from HUD.

With approval of Amendment No. 4, Tarrant County will provide Tarrant County Hands of Hope with \$5,305.05 in additional unallocated ESG-CV grant funds to close out this grant. The unallocated ESG-CV funds will be used to reimburse costs allocated during the service term. Total reimbursement will not exceed \$314,395.05.

This agreement covers eligible services provided by Tarrant County Hands of Hope during the period of March 1, 2020 through June 30, 2024. Final reports must be received by Tarrant County by September 30, 2024.

The Criminal District Attorney's Office has reviewed this contract as to form.

FISCAL IMPACT

Costs associated with administration of this contract are paid with grant funds through Grant #E-20-UW-48-0001-CV. There are no match requirements.

Dear Mr. Ramsey:

On March 9, 2021, Tarrant County and **Tarrant County Hands of Hope** entered into the above-referenced contract (the "Contract"). By notice of this letter, Tarrant County proposes to amend the Contract concerning the following terms contained within the **Scope of Services** as follows:

11. SCOPE OF SERVICES

From the proceeds awarded to the County under the Emergency Solutions Grant – CV Program (the "Grant"), the County will reimburse the Agency a budgeted amount for providing emergency services for the homeless in response to the COVID-19 pandemic. The County will reimburse The Agency for operating and essential service expenses. Eligible expenses include staffing, increased utilities, and supplies for COVID-19 temporary non-medical service delivery at an emergency homeless shelter or through street outreach.

Approved Budget: The total project budget for Emergency Solutions Grant Program # E-20- UC-48-0001-CV is \$4,059,159. The County, upon submission of written requests from the Agency, will reimburse the Agency out of the total project budget for allowable expenditures up to, but not exceeding, the following specified amounts:

The County will reimburse the Agency for this service upon timely submission of a monthly statement of expenditures. The County will not reimburse the Agency for ineligible expenses or expenses incurred in excess of the maximum reimbursement amount under the total project budget.

Match Requirement: The ESG-CV program requires no match.
