COMMISSIONERS COURT ACTION REQUESTED:

It is requested that the Commissioners Court award RFP No. 2020-191, Hazardous Materials Emergency Response, Remediation Services, and Waste Disposal, Countywide, to the following vendors at the per contract terms:

Primary	TAS Environmental Services, LP
Secondary	Spur Industrial, LLC, d/b/a Spur Environmental Services, LLC
Alternate	US Ecology Houston, Inc.

BACKGROUND:

Notice of the County's intent to bid was advertised in local newspapers, as required by State statute, and posted on the Internet, the Arlington Black Chamber of Commerce, the Fort Worth Hispanic Chamber of Commerce, the Fort Worth Metropolitan Black Chamber of Commerce, and the Tarrant County Asian American Chamber of Commerce. Three hundred thirty-four (334) vendors were contacted and requested to participate in this proposal process. All documents pertaining to this RFP were posted on the Tarrant County website and were downloaded by interested parties. A pre-proposal conference held on September 10, 2020 was attended by eight (8) vendors as well as representatives from Transportation Services and Purchasing. Five (5) proposals and one (1) no-bid were received.

Proposals were evaluated by Transportation Services and Purchasing representatives. Evaluations were based upon the criteria and processes set forth in the RFP.

The term of the contract is twelve (12) months, effective January 1, 2021, with two (2) options for renewal periods of twelve (12) months each.

Therefore, it is the joint recommendation of Transportation Services and Purchasing that RFP No. 2020-191, Hazardous Materials Emergency Response, Remediation Services, and Waste Disposal, be awarded to the vendors listed above at the per contract terms.

FISCAL IMPACT:

Expenses for last year were approximately \$6,639.13. Services are provided on an as-needed basis.
