We should do better at the county level by selecting major races and with 30% of the ballots out of the whole population of the election data. before we could have a real full election audit, enlarging the manual count scale would help ensuring our election integrity and transparency.

- Poorly administered voting processes - Only 30% accuracy in May / June 2021 Election Day "Register of Official Ballots" Reconciliations across all voting locations
- Gross violations of election procedures at certain in-person voting locations in May / June, 2021 and the recent 2022 primaries
- "Rally Site" internet transmission of hackable "unofficial votes" to the main election office which then sit on an internet-connected server for the duration of the election, again totally hackable. Tarrant is the last known county in Texas to do it this way, all at a cost double that of Denton County with hand-marked paper ballots, digital ballot images, scanner tabulation for site reconciliation and central office delivery.
